RESERVING A DEVICE:

The **AMI 850** is the next evolution of the **AMI 750**. A \$500 deposit is required to reserve the **AMI 850**. Our bookkeeper will email you an invoice for the \$500 deposit. This amount will be applied to the purchase price when your device ships. Your device is expected to ship within 60 days of your deposit. Two weeks prior to your ship date you will receive a final invoice from our bookkeeper, “CymaOrders@gmail.com “

In the event you decide to withdraw from the reservation list before the shipping date, the deposit is refundable.

At this time, the **AMI 500** is sold out and is not expected to be available until summer of 2023.

RETURN POLICY We offer a 30-day money back guarantee. If within the first 30 days of ownership you decide to return your AMI device, we refund your purchase price, minus a 15% restocking fee and cost of shipping.

WARRANTY The AMI devices come with a one-year warranty for all parts and labor, with one exception. Those products which use gel pads have a 90-day warranty for them specifically. Replacement foot pads
